That Lock 1 Marina in consideration of the fee schedule listed will provide winter storage to the boat described below. The winter season will begin on or about October 1, 2011 and ends May 1, 2012. Any boats not launched after May 15, 2012 without a paid summer slip contract, will incur summer storage fees. No refunds will be made if this agreement is canceled prior to its expiration date. If your boat is stored where it blocks another boater from launching in the spring, extra fees will incur if your boat needs to be moved and re-blocked. The boat owner is responsible for having valid insurance coverage on the boat while stored.

EXAMPLE: 30 X 25 = \$750.00 (X .07 SALES TAX= \$52.50) =\$802.50

.....If you plan to pay at haul out after October 1, 2011.....
A \$300 deposit must accompany this contract to secure your storage space. Payment is due in full upon haul out.
Storage on Blocks and Stands- \$27/ft overall length; Boats on Trailers \$16/ft plus 3 feet for trailer.
